








## WHAT IS THE RDOS?


ADVOCACY - RDOS aims to bring about positive change, protect rights, or address issues of concern to recreational dock owners in the Vancouver Fraser Port Authority jurisdiction by raising awareness, mobilizing support, and seeking solutions through various channels such as lobbying, campaigning, or public education.



AGREEMENT CLARITY - RDOS aims to break down the complexity of proposed dock licenses, so everyone can grasp what's being communicated without getting overwhelmed by jargon. We want agreements that make sense to everyone.



AGREEMENT FAIRNESS - Ensuring that all parties involved in dock negotiations are treated justly and equitably, with their interests and rights taken into consideration. RDOS aims to create transparent and balanced terms that result in mutually satisfactory outcomes for everyone involved.



### COLLECTIVE LEGAL REPRESENTATION - Joining

RDOS builds a groundswell of those impacted, as we coordinate legal representation, and share costs as a group of dock owners collectively, prior to finalizing any proposed dock agreements with the VFPA. We are more powerful negotiating together as a group of owners.

#### RECREATIONAL DOCK OWNER PROPOSED LICENSING - TIMELINE OF EVENTS

#### **MARCH 2023**

#### Vancouver Fraser Port Authority Sends New Proposed Licensing Agreement

VFPA sends proposed license agreements. (Most license holders have signed 1996 license agreements - although of approximately 500 waterfront homes some have no license).

#### **APRIL 2023**

#### Alderside Residents Committee (ARC) is Formed

ARC communicates with residents of Port Moody and surrounding areas.

#### **JULY 2023**

#### ARC Hosts Townhall, Invites VFPA. VFPA Declines Invite.

Alderside Residents Committee invites Jennifer Natland and some other Vancouver Fraser Port Authority reps to attend. Invitation declined by VFPA, 65 in attendance.

#### **AUGUST 2023**

#### VFPA Announces Zoom Meeting, Invites 21 Stakeholders

VFPA announces they will host a Zoom meeting to address the concerns people have. They invite 21 attendees.

#### **AUGUST 2023**

#### **ARC Rallies Affected Property Owners**

ARC distributes notices dock to dock, door to door, to over 200 concerned property owners in the VFPA jurisdiction.

#### RECREATIONAL DOCK OWNER PROPOSED LICENSING - TIMELINE OF EVENTS

#### **AUGUST 2023**

#### 200+ Attend VFPA Zoom Meeting - ARC Campaign Boosts Attendance from 21 to 200+

Due to ARC distribution notices, over 200 attendees on call confirmed by moderator Pam Ryan. The Zoom meeting is summarized as some of the issues on a heavily moderated call were addressed, however many primary concerns were not.

#### **AUGUST 2023**

#### **VFPA Assures Meeting Participants Answers to Questions Asked**

Response received late September 2023, with a written transcript of the meeting with a recorded video. No other communication surrounding answers to questions was provided.

#### **SEPTEMBER 2023**

# ARC Forms Residential Dock Owner Society (RDOS) to Ensure All Concerned Property Owners are Included

ARC forms the "Recreational Dock Owner Society" (RDOS) and is actively driving membership to coordinate a single entity to be represented in this matter.

#### **FEBRUARY 2024**

#### **RDOS Engages Legal Representation and Informs VFPA**

Letter sent to VFPA to let them know the RDOS has engaged legal representation and requests they issue communications sent to members to legal counsel as well.

# PROPOSED DOCK LICENSE ISSUES & UPDATES

- License is for 10 years with option for just one additional 10 year period (old licenses never had an expiration but options to renew)
- Fee increase by a factor greater than 15X will be imposed starting 2025 (from \$140 currently to \$600, \$1200, or \$2000 per annum depending upon your location)
- Cancellation of license without cause with 15 months notice
- Questionable if license can be transferred to new property owners in the event of a sale of the upland property
- Potential removal of unauthorized boathouse and ramp structures prior to the sale of the upland property
- Lack of consultation with affected stakeholders by VFPA and being dismissive of our concerns
- No compensation for the constructive expropriation of waterfront property value
- New covenants and administration (Land Title Office) costs borne by YOU!

# 'Egregious terms' prompt dock owners to refuse to sign port's new contract

Waterfront property owners in Port Moody say their docks are under threat, not from rot or a storm, but a new licensing agreement.

Residents on Alderside Road said they were shocked when they received new contracts from the Vancouver Fraser Port Authority process, according to the port authority. The port said the changes were necessary as the program had not been updated in decades.

But for residents of Alderside Road, the terms appear to go far beyond that.

"I was just blown away," said Dennis Nisbet, a retired real estate agent. "This contract is so one-sid-

# Waterfront owners in Port moody refusing to sign port authority's 'egregious' dock-licensing terms

Waterfront property owners in Port Moody say their docks are under threat, not from rot or a storm, but an new licensing agreement.

Residents on Alderside Road said they were shocked when they received new contracts from the Vancouver Fraser Port Authority (VFPA) in March 2023.

They claim the updated terms strip away their rights, and open the door to completely losing access to their docks and foreshore lots in the future.

Owners were initially given a April 30, 2023 deadline to sign, but many have refused.

• "This is about the erosion of our rights," said Ryan Sayer, an Alderside Road resident. "If these egregious terms are to remain in these agreements, we're not going to sign."

Affected residents have organized town halls, formed a dock-protection society, contacted their
